### Call to order

- Meeting called to order at 3:46 pm by **C. Hernandez**.

### Introductions

- **C. Hernandez:** Welcome to Alyssa Kaufman! **A. Kauffman:** I was an adjunct faculty member starting in 2000, full time since 2007, and DE certified since 2022. I've taught in four of the six modalities (not combined online or Sufflex). I teach in communication studies and I do study hour.

### **Modalities definitions chart**

- **C. Eaton** shares the different approaches to the modalities definitions charts: One with the left/right arrow, and the second that resides in MySCCC and includes screenshots of how courses appear in Banner. Feedback:
  - Good to have different ways to represent but definitions need to be the same
  - Color coding should be the same between them; colors need to be ADA compliant
  - Needs to have posted in a place that's helpful for students
  - Needs to have language that makes sense for students  
Alyssa: Registrar and language – students can find it on the website and don't read it or always understand the language

### **FA contractual provisions impacting DE**

- **C. Eaton:** As negotiated in the last memo of agreement, which is on the FA website, the understanding at the negotiations table is that at a bare minimum all faculty in all modalities must upload their syllabus/course outline. **R. Hill:** There are no reports for how many faculty have accessed their Brightspace shell. Also, ADA compliance needs to be ensured; how do we do that? **C. Eaton:** I believe you have resources already available, yes? **C. Hernandez:** We in CTL can look at that.

- Can any synchronous meetings be mandated in asynchronous classes? Answer is still unclear. Need to see if there is guidance from SUNY or Middle States.
- Will discuss any need for substitutes for governance reps like there is for the union rep. Just need to ensure in keeping with contractual requirement that at least one is a DE practitioner.
